- Gained extensive hands-on experience, collaborating with election staff to manage unpredictable, high-volume election period challenges during the 2025 primary, demonstrating crisis management and commitment to election integrity
  - Learned and executed language assistance procedures at check-in and the voting machine for two large non-English-speaking voter groups—one with an interpreter and one without—each unexpectedly arriving en masse, with groups of 12–20
  - Learned and executed provisional balloting procedures on-site, identifying whether English or Spanish instructions on the ballot envelope would best support limited-English-speaking voters, to ensure accurate ballot submission
  - Learned and executed check-in procedures in real time to facilitate voting for individuals with disabilities, adapting processes under ADA election regulations
  - Identified and escalated a rare voter ID verification failure at check-in between voter self-identification, the standard driver's license scan – typically the most reliable method of voter identification – and voter registration records, ensuring the voter was verified to vote
